

# Frequently Asked Questions

## IIBA 20% Exam Rebate Promotion

### 1. What is IIBA's exam rebate promotion, and when does it start?

Starting November 1, 2023, IIBA is offering a 20% exam rebate for its entire range of certifications, including [ECBA](#)<sup>™</sup>, [CCBA](#)<sup>®</sup>, [CBAP](#)<sup>®</sup>, [IIBA](#)<sup>®</sup>-AAC, [IIBA](#)<sup>®</sup>-CBDA, [IIBA](#)<sup>®</sup>-CCA, and [IIBA](#)<sup>®</sup>-CPOA when the exam is written by December 29, 2023, 11:59 PM Eastern Time (ET).

### 2. Who is eligible for this exam rebate promotion?

This promotion is exclusively available to IIBA Members in good standing. To be eligible, you must be an IIBA Member and take the exam between November 1 and December 29, 2023. If you are not an IIBA Member, purchase your Membership [here](#) first to be eligible for this offer.

### 3. Do I need a special code to apply for the rebate?

No special codes are required. The rebate will automatically apply to eligible IIBA Members who complete an exam within the promotional period.

### 4. What does the 20% exam rebate cover?

The 20% exam rebate applies to all exam fees and exam rewrite fees only.

### 5. When will I receive the rebate, and how will it be processed?

The rebate will be applied to the original payment method after the exam is completed in USD. Please note that it may take up to January 15, 2024, for the rebate to be processed.

### 6. Can I expect the rebate amount to match the original purchase price due to currency exchange rates?

Currency exchange rates fluctuate daily, so the amount refunded may slightly differ from the purchase price. The rebate will be processed in USD.

### 7. Does this promotion apply to bundled pricing for exams?

Yes, the exam rebate applies to the exam portion of the [IIBA](#)<sup>®</sup>-CCA and [IIBA](#)<sup>®</sup>-CPOA bundled prices.

### 8. Can I use this promotion for bulk exam purchases?

No, this offer does not apply to bulk purchasing or volume purchase agreements (VPA). It is valid for individual exams only.

### **9. Can I schedule and take the exam on the same day as the exam purchase?**

No, you cannot take the exam on the same day as the exam purchase. **Exam scheduling availability is determined by the exam fulfillment service.** We recommend scheduling your exam quickly to ensure you get your preferred date and time, as spots can fill up quickly with offers like this. Please plan accordingly when scheduling your exam.

### **10. Can this promotion be combined with other IIBA offers?**

No, the offer may not be used in conjunction with any other IIBA promotional codes, discounts or offers.
